

Our IR Privacy Policy

This Investor Relations Website ("IR Website") is designed and maintained by Matang Berhad (hereinafter referred to as "Matang", "we", "our" or "us") and any pages thereof including but not limited to the information, text, images, links, sound, graphics and video sequences displayed therein are referred to as the "Materials".

This IR Privacy Policy sets out our practices pertaining to the collection, store, use and process of your personal information we collect from you within the IR Website. This Privacy Policy applies when you use this IR Website as a casual browser. From time to time, please review any changes that may have been made on the IR Website and we serve the right to change this Privacy Policy at our sole discretion from time to time.

Collection of Personal Information

Personal information on this IR Website may be collected by us from time to time when you visit or browse our IR Website but you can also visit the IR Website as a casual browser without providing personal information.

We may collect your personal information when you write to us through email address included or indicated in the IR Website. We may store and process your personal information which include your name and email address.

In addition, we will collect and use your personal information at any times and from time to time (including but not limited to) only where we have legitimate reasons and are legally entitled to do so, or when it is required to verify your personal information by us, the Company or our service providers for the following situations:

- when you request for services or technical support;
- when you report a problem or make any inquiries or suggestions in respect of the IR Website; or
- when you contact Matang, we may keep a record or a copy of that correspondence.

When you browse the IR Website, we may automatically receive information about your interaction with the IR Website which will be stored in our server log files. This information includes your internet protocol ("IP") address, browser type, operating system, date and time of your visit, cookie information, the extent of repeat usage, usage by registered and unregistered users, pages you have seen in each service requested, users progress, number of entries, submissions and status in services, traffic patterns, areas of the IR Website you have visited and your visiting patterns in the aggregate.

Use of Information

In general, Matang does not sell nor does it intend to sell your personal information to anyone or any organisation. The information which we collect from you will be used in the ordinary course of business including but not limited to the provision of specific services to you as requested, to prevent any fraud or illegal activities, and to prepare statistics concerning the visitors' use of our services and the IR Website.

Save as provided in this Privacy Policy, we will notify you at the time of data collection or transfer if your data will be shared with a third party and you will always have the option of not permitting the transfer.

We may use your email address to contact you to reply any email you send to us or regarding administrative notices, reminders, legal processes, and communications relevant to your use of the IR Website. Information that we maintain about you and information from your current and past activities on the IR Website will be used in the event of troubleshooting or disputes.

Sharing of Information

Matang will not share your personal information with any third party unless: -

- your consent is obtained;
- a service provided on the IR Website requires interaction with a third party or is provided by a third party;
- if required by law or pursuant to legal action or law enforcement;
- the IR Website is purchased by a third party as a result of which the third party is entitled to use the data in the same manner as set forth in this Privacy Policy; or
- under special circumstances such as when we believe in good faith that the law requires it or under the circumstances described below.

Some of the user data in the aggregate will be used to compile statistics that shows, by for example, the numbers and frequency of the users using the IR Website or viewing individual contents. These aggregated statistics do not contain any personally identifying information about you. Matang may disclose such aggregated statistics in order to describe certain statistics of our current and prospective visitors or users to the IR Website, our clients, business partners, advertisers and other third parties, and/or for other lawful purposes.

In the event where Matang has reason to believe that you are violating or may be in breach of the Terms of Use or any written law, we may disclose the information we have about you obtained through the IR Website to third parties to the extent that it is reasonably necessary to prevent, remedy or take action in respect of such conduct or to ensure Matang complies with any laws in force from time to time.

Matang may disclose or access your user account information including your email address or other contact details obtained from you or provided by you through the use of this IR Website when we believe in good faith that we are obliged to comply with any legal obligations, or we are permitted by law to do so or otherwise to protect ourselves or the Company.

Data Security

Matang will use its commercially reasonable effort to safeguard your personal information we collect from you online. When we outsource any processes, we will also ensure that our service provider has applied appropriate security measure and that your personal information is treated securely. When you give your personal information, that information may be sent electronically to servers within the territorial of Malaysia irrespective of where you originally entered the information. Unfortunately, no data transmission over the Internet can be guaranteed to be completely secure. Despite our efforts to protect your personal information, we do not warrant the security of any information you transmit to us, or from our online services. Accordingly, all such transmission of information is carried out at your own risk.

Cookies

In common with many other website operators, Matang may (but not necessary will) use cookies to validate, store and sometimes track information about your use of the IR Website. Cookies are small text file that are sent to your browser from a web server and stored on your computer by acting as a sort of "bookmark" within the website. It enables system to recognise a user preference and respond appropriately, and cannot be executed as code or deliver viruses. No personal information is stored within the cookies.

We may use cookies for the following reasons:

- It enables the system to deliver a better user preference and personalised content that a user, visitor to our IR Website will see on certain parts of the IR Website; and
- It enables the system to monitor the IR Website performance and to identify any areas of the IR Website that may need maintenance.

Most browsers automatically accept cookies. You can modify your browser to prevent cookies being stored but to do so you may not be able to use certain parts of the IR Website.
