BASED ON THE TERMS AND CONDITIONS AND DETAILS AS SET OUT IN THIS REQUEST FOR TENDER AND THE TENDER PRICE (AS DEFINED BELOW) SUBMITTED BY THE TENDERERS, MATANG HOLDINGS BERHAD ("MHB" OR "COMPANY") IS SEEKING TENDER SUBMISSION FROM TENDERERS ("TENDERERS" OR "BUYERS") FOR THE PURCHASE OF TWO UNITS OF USED FOUR WHEEL DRIVE TOYOTA HILUX.

TERMS & CONDITIONS

1. Our company, MHB, would like to dispose two (2) units of used Toyota Hilux via **tender on as-is-where-is basis**, with summary of details as follows:
