As part of the complete Tender Documents, interested tenderers shall submit all of the following:

1. The duly completed and signed (on each page) of the following:
 - a. Appendix 1: Summary of Tender Price
 - b. Appendix 2: Detailed Specification
 - c. Appendix 3: Confirmation of the Tenderer/Supplier.
2. Fertilizer delivery date shall be as per the delivery date as specified in Appendix 1. In the event the delivery schedule cannot be completed, the delivery period may be extended for another 14 days without penalty.

In the event the fertilizers are not delivered after 14 days extension, or other dates agreed by both parties or fails to deliver part of the consignment for any reason whatsoever except due to Force Majeure event, MAPYP reserve the right to impose the following:

- a) Penalty of 1% of value of agreed Tender / Purchase Order ("PO") price of fertilizers so delayed, subject to a maximum penalty of 5% of agreed Tender / PO price of the fertilizers;
 - b) Matang may look for alternative sources to purchase fertilizer and charge the difference in costs to the Supplier.
3. For fertilizer and / or alternative fertilizer quoted, please indicate specially in your Quotation the specifications in details in Appendix 2.
4. Tenderer / supplier are to provide one round leaf sampling test for Matang Estate (planted area 37.64 Ha) upon request.
5. Price per bag shall be inclusive of delivery charges and unloading cost to the fertilizer store in the Estate.
6. Term of payment: 60 days from the date of invoice received, subject to no short weight and satisfactory lab test on percentage of both individual and total nutrient in fertilizer purchased. For avoidance of doubt and clarification purposes,

1. Short Weight

- a) All delivery of fertilizer will be weighed at pre-determined weighbridge by the Estate.
- b) In the event of short weight ie, difference between MAPYP weighbridge weight versus Supplier declared weight, MAPYP is obligated for the following actions:
 - i) MAPYP shall count the number of bags supplied in that particular load and note it accordingly in the Delivery Note / Order or Collection advice for Supplier immediate action.
 - ii) MAPYP shall duly inform the Supplier within 3 days of receipt of fertilizer.

The supplier shall respond within 3 working days of receipt of notice and arrange the following follow up actions:

- i) Send a representative to Matang estate or warehouse to randomly weigh the bags retained in the store.
 - ii) Provide weighbridge details of deliveries to date to establish overall weighment against the particular order.
- c) Should the random weighment and the overall weighment for cumulative loads show a short weight status then the Supplier shall either:
 - i) Replace the established short weigh amount; or
 - ii) Compensate Matang by issuing a Credit Note.

2. Quality/Nutrient of Fertilizer

- a) The fertilizer to be supplied shall conform to the relevant standards as per SIRIM standard and specification determine by MAPYP. In the event MAPYP finds that some or all the fertilizers supplied do not conform to these standards, MAPYP shall duly notify the Supplier and not apply the particular lot of fertilizers.
- b) The **Supplier shall conduct one (1) joint sampling with the Estate during fertilizer delivery**. The Supplier is required to perform the joint sampling upon the arrival of the fertilizers at the Estate. All sampling and testing shall follow SIRIM's procedures, and **the samples shall be tested at one (1) mutually agreed independent laboratory**. Should the test results indicate that the fertilizers supplied do not meet the required specifications, the Supplier shall compensate MAPYP proportionately based on the value of the fertilizers found to be under specification.

- c) The calculation of the compensation amount arising from any nutrient shortage shall follow the penalty formulae prescribed as follows:

NUTRIENTS SHORTAGE

In the event of any shortage in nutrient content from the allowed variation as specified in Appendix 2. A claim shall be made from the Supplier according to the formulae stated below. The principle used in calculating the penalty (P1) or (P2) or (P3) is double the combined value of losses due to:-

- a. Fertilizer nutrient shortage and
- b. Incidental and handling charges at RM50 per MT of fertilizer.

Upon receipt of the Analytical Results from the appointed laboratory the Estate shall make the claim directly to the supplier in the relevant forms (a copy of each form is attached) with a carbon copy to Finance Dept.

INDIVIDUAL NUTRIENT SHORTAGE IN MIXTURES /COMPOUNDS

Where any one or more of the major nutrients (N, P₂O₅, K₂O) are short by:-

12% - Individual Nutrient in Mixture

8% - Individual Nutrient in Compound

The penalty is calculated as follows:-

Penalty (P₂) in Ringgit (RM) is $P_2 = 2W (D+H)$

Where:-

W = Total weight (MT) of straight fertilizer** required to replace the nutrient shortage.

$$W = \frac{(X_2 - Y_2)B}{M}$$

X₂ = Total % Nutrient Specified*

Y₂ = Total % Nutrient Analyzed*

B = Total Weight in metric ton (MT) of batch of Mixture/Compound fertilizer received.

D = Price of the replacement straight fertilizer**

M = % nutrient specified in replacement straight fertilizer required to make up the nutrient shortage**

* The major nutrients are Nitrogen (N), Phosphorus (P₂O₅) and Potassium (K₂O)

**The appropriate straight fertilizers for the nutrients N, P₂O₅ and K₂O are Ammonium Sulphate (21%N), Rock Phosphate (30%P₂O₅) and Muriate of Potash (60%K₂O) respectively.

As shortage of Magnesium (MgO) and trace elements are small, it can be generally ignored.

Where there is more than one nutrient shortage in the mixtures/compound fertilizer then the Total Penalty shall be the sum of penalties for individual nutrient shortages.

SHORTAGE IN BOTH INDIVIDUAL AND TOTAL NUTRIENT IN MIXTURE OR COMPOUND FERTILIZER

In the event of both individual and total constituent nutrient shortage in Mixture or Compound Fertilizer arise, then Penalty shall be made on the highest value (Ringgit), either on Individual or Total nutrient.
